Why join CFDT?

Whichever site you are attached to (Nice, Paris, or Strasbourg), as a member, you can:

Benefit from active listening at your workplace (and at CFDT reception points). With CFDT, you are no longer alone facing management. Take advantage of the network and expertise of CFDT activists (working

conditions, training, transfers, conflicts, etc.).

Access the member area on cfdt.fr, where you'll find a publication kiosk (CFDT Magazine, Syndicalisme Hebdo, etc.) and practical services: "Réponses à la carte" (answers to all your questions, including those related to your private life).

Receive assistance from a defender and/or lawyer. If you have been a member for more than 6 months, the costs will be covered by the union. Membership cost depends on your salary and is eligible for a 66% tax credit. Ie: For a NET monthly salary of  $\leqslant 3,000$ , the monthly contribution is  $\leqslant 22.50$ , and after the tax benefit, the actual cost is only  $\leqslant 7.65$  per month.
